THE ORGANIZATION PROCURES UNSELLABLE, BUT EDIBLE, FOOD FROM THE FOOD INDUSTRY, RECEIVES DIRECT DONATIONS OF FOOD, ADMINISTERS SOME GOVERNMENT FOOD PROGRAMS (TEFAP/USDA/SUMMER FOOD PROGRAMS), AND PURCHASES FOOD FROM WHOLESALEERS. FOOD IS SORTED AND PACKAGED AND DELIVERED TO MORE THAN 100 OTHER NONPROFIT AGENCIES SUCH AS HOMELESS SHELTERS, FOOD PANTRIES, LOW INCOME HOUSING, AND AFTER SCHOOL PROGRAMS, WHO THEN DISTRIBUTE THE FOOD TO PEOPLE IN NEED THROUGHOUT WASHTENAW COUNTY. IN THE LAST FISCAL YEAR, WE DISTRIBUTED OVER 6 MILLION POUNDS OF FOOD, MORE THAN TWO-THIRDS OF WHICH WAS PRODUCE AND PROTEIN ITEMS. ADDITIONALLY, \$369,102 WAS DISTRIBUTED TO PARTNER AGENCIES IN THE FORM OF CREDITS FOR FOOD PURCHASING AND \$51,750 IN CASH GRANTS WERE AWARDED TO PARTNER AGENCIES FOR CAPACITY BUILDING

STUDENTS OBTAIN MARKETABLE SKILLS AT THE SAME TIME THEY ARE FEEDING NEIGHBORS IN NEED. BY TARGETING YOUNG ADULTS WHO ARE OFTEN RECIPIENTS OF FOOD ASSISTANCE, THE HOPE IS TO HELP THEM SECURE GAINFUL EMPLOYMENT IN THE FOOD INDUSTRY. THE TRAINING CURRICULUM REFLECTS THE SKILLS AND EXPERIENCE THAT LOCAL FOOD SERVICE EMPLOYERS ARE SEEKING. FOOD GATHERERS ALSO OFFERS PAID INTERNSHIPS AT THE WAREHOUSE OR THE KITCHEN TO GRADUATES. AS OF SEPTEMBER 2016, 159 STUDENTS HAVE GRADUATED FROM THE PROGRAM.
